ACSESS Retail Sales Tax lobbying efforts saved Ontario and British Columbia members millions.

Ministries of Finance of BC and Ontario Information Notices re Agencies placing Temporary IT Consultants confirmed that RST may not apply to certain fees charged for placement services, a very significant victory for ACSESS and our members specializing in the supply of IT consultants.

ACSESS Ontario Employment Standards Act lobbying efforts saved employers in the staffing industry millions of dollars.

The successful conclusion of ACSESS lobby efforts on Employment Standards Act, Public Holidays provisions, allowed the staffing industry to benefit from an exemption from the public holidays provision provided in Part X of the ESA.

ACSESS developed prevention materials for members in Ontario, Alberta and Nova Scotia;

ACSESS developed an industry specific Pay Equity compliance tool for Quebec members;

ACSESS successfully defended Quebec members' status as employers in response to ongoing policy issues related to the Labour Code, Employment Standards and the Commission de la santé et de la sécurité du travail;

ACSESS British Columbia WCB lobbying efforts resulted in a substantial reduction in premiums and tremendous savings for members;

ACSESS sponsored Safety Group program has resulted in a significant reduction in WSIB premiums and millions in direct financial returns to Ontario members.
